- 1) Rs. 500/- application fee (Non-refundable)
- 2) Rs. 5000/- Deposit amount (Refundable) after completion of tender process.
- 3) Agree to accept the lowest bidder in the tenders.
- 4) Vehicle should be as per the specified norms for transportation of sheep.
- 5) Necessary modifications suitable for transportation of sheep have to be made by the transporter
- 6) The transporter will be responsible for safe transportation of sheep up to the destination of individual beneficiary.
- 7) If failed to complete the work, I am liable for legal prosecution and I will forego the deposited amount of Rs. 5,000/-.
- 8) All rights are reserved with the department only i.e., approval and cancellation of tenders in case of bid not received within the allotted budget and subject to allocation of budget by the Government.
- 9) All legal prosecutions will be under jurisdiction of Siddipet District Court only.
- 10) Self attested Xerox copies of necessary documents and permits should be enclosed with this application form.
- 11) Filled in application along with Rate quotation in sealed cover should reach this office on or before 10.01.2018 by 5.00 PM.
- 12) To transport all the sheep safely to the destination Place, proper spacing and height should be provided in the vehicle.
- 13) The transportation should be in the night hours.
- 14) Each adult should be provided 3.2 Sq. Ft Floor space and each lamb should be provided 1.6 Sq. Ft. Floor space in travel vehicle.
- 15) To facilitate for comfortable transportation, minimum of 3 sheep units (63 Sheep s only) of one particular mandal should be loaded in one vehicle.
- 16) Depending upon the journey, sufficient fodder and water should be made available to the sheep being transported in the vehicle.
- 17) There should be provision for 4 to 6 beneficiaries to travel in the vehicle.
- 18) If the travel time is expected to be more than 8 hours, giving rest for one day and allowing sheep to graze in day time is mandatory.
- 19) I agree to deduct 1 % TDS OR if Firm 2% TDS FROM transportation of sheep amount from each bill.
